Hi Elizabeth, Mark,

Many thanks for your time on the call last week, it was good to catch up.

As promised, please find attached the wireframes for the 149.9m and 180m tip heights and also the comparative ZTV (I've split over 2 emails). I've also included a short summary of the update below:

Ministry of Defence:

- The MoD have accepted the NAIZ mitigation put forward to address their concern about impact to the Air Defence Radar at Buchan
- Currently discussing the proposed planning conditions, and hope to have those agreed next month which should then allow MoD to remove objection

NATS:

- On-going discussions to put in place standard Mitigation agreement
- Hope to have this finalised in next 6 weeks, which should allow NATS to remove objection

Scottish Natural Heritage response:

- Hope to set up a meeting with SNH (and yourselves) to discuss their response
- Wireframes and comparative ZTV produced to look at differences between 180 and 149.9m tip height
- Alternative Lighting Strategy report currently being drafted by Osprey (aviation consultants) which hopes to minimise number and intensity of lights required
- Alternative Lighting Strategy to be discussed with Civil Aviation Authority

Ecology clarifications:

- Clarifications for Aberdeenshire Council ecology team to be sent out by 10<sup>th</sup> July

I will keep you posted on how the aviation matters progress, and we will be in touch in due course to look at dates for a meeting with SNH.
