An Environmental Impact Assessment Report (EIAR) has been prepared in support of an application submitted by Natural Power Consultants (Natural Power) on behalf of the Applicant, Vattenfall Wind Power Ltd. The application seeks consent under Section 36 of the Electricity Act 1989 and the EIAR has been prepared in accordance with the Electricity Works (Environmental Impact Assessment) (Scotland) Regulations 2017. The application also seeks a direction under Section 57(2) of the Town and Country Planning (Scotland) Act 1997 as amended that planning permission for the development be deemed to be granted. This EIAR contains the information relating to the Environmental Impact Assessment to develop a wind farm comprising of up to 11 turbines and associated infrastructure (the Proposed Development). The Proposed Development is situated south-east of the B741, south of Dalmellington and south-west of New Cumnock, in East Ayrshire.

This is Volume 2a of 4, of the EIAR. This volume presents the EIAR Figures except for LVIA.
